

**The Admission process of FOREIGN CITIZENS
to English-language educational programs “Medicine”, “Dentistry”
(2026-2027 academic year)**

I. SUBMISSION OF DOCUMENTS

1. For admission to KazNMU, foreign citizens need to apply to Companies cooperating with the university. The list of the Companies and their contacts are posted on the university website.

2. Foreign citizens submit the following documents to the admission committee of KazNMU through representatives of the Companies:

1) application for documents acceptance;

2) copy of passport. The validity of the national passport must be at least 2 years at the time of submission of documents.;

If you don't have a passport, a copy of your ID is provided.

Please note that at the time of enrollment to the university (after successfully passing the interview) you will be required to present a passport.

3) copy of the document on education with the transcript. The original document of education must be apostilled, that is, have a stamp certifying the authenticity of the signature of the person who signed the document and confirming the authority of this person, as well as the authenticity of the seal or stamp that this document is sealed with;

4) copy of certificate of National Eligibility cum Entrance Test (NEET) for citizens of the Republic of India;

5) international certificate confirming English language proficiency:

IELTS Academic – minimum score of 5.0

TOEFL iBT – minimum score of 35

TOEFL ITP – minimum score of 417

TOEIC – minimum score of 550

Duolingo English Test – minimum score of 80

All documents must be in PDF format, in excellent quality!

An incomplete package of documents is not considered by the admissions committee.

If necessary, the admission committee has the right to request additional documents.

3. After checking the documents, the admission committee sends a letter to the applicant stating that he is allowed to interview, including in an online format.

The letter is an electronic document of KazNMU, which can be checked by the applicant through the portal <https://kaznmu.isirius.kz/> by entering the "Unique Code" specified in the letter.

II. INTERVIEW

1. Admission of foreign citizens for training is carried out based on the results of the interview. During the interview, the applicant must demonstrate general education, life experience, their beliefs and achievements, life position and worldview.
2. The schedule of the interview is posted on the website of the university, and is also given to the Companies.

Please keep up to actual information on our website!

3. The admission of an applicant for an interview is carried out upon presentation of an identity document.
4. The minimum interview score is not less than 60% of the maximum score.

Sample interview topics:

- *What influenced your choice of profession in your life?*
- *What contribution do you plan to make to medicine?*
- *What experience of interaction or work in medicine do you have? Have you worked as a volunteer in medicine?*
- *What are your personal qualities that will help you become a good doctor?*
- *Why did you choose the profession of a doctor?*
- *What qualities should a good doctor have?*
- *What does the expression "Do no harm" mean?*
- *What difficulties do doctors face besides the illness of patients?*
- *What is a virus and how does it differ from a bacterium? What is vaccination and why is it needed?*
- *Do you think artificial intelligence affects the work of a doctor?*
- *How do the Internet and gadgets help or hinder medical practice?*
- *How do you feel when someone nearby is suffering or ill?*
- *What qualities would you like to develop in order to be a good doctor?*
- *How do you feel about criticism?*
- *Imagine that a frightened child with a sore arm comes to you. What will you tell him?*

III. SELECTION

1. After the interview a competitive selection is carried out in accordance with the admission plan.
2. The admission committee notifies the representatives of the Companies about the results of the selection on the day of its holding.

IV. UNIVERSITY ENROLLMENT

1. The order on the admission of foreign citizens to the number of students of KazNMU is issued on the basis of the results of the selection and submission to the admission committee by representatives of the Companies of the original documents.

List of documents for enrollment:

- 1) application;
- 2) questionnaire;

3) passport (returned after verification), a copy of the passport with a notarized translation into Kazakh or Russian. The validity of the national passport must be at least 2 years at the time of submission of documents.

4) document on education (original) with attachment/transcript (original). Education document (original) must be apostilled;

5) notarized translations of the passport, education document and application/transcript into Kazakh or Russian. Certification of translations is carried out by a notary in the territory of the Republic of Kazakhstan or by the diplomatic service of the Republic of Kazakhstan in the country in which the document was issued;

6) national Eligibility cum Entrance Test (NEET) certificate for citizens of the Republic of India;

7) international certificate confirming English language proficiency:

IELTS Academic – minimum score of 5.0

TOEFL iBT – minimum score of 35

TOEFL ITP – minimum score of 417

TOEIC – minimum score of 550

Duolingo English Test – minimum score of 80.

8) medical certificate in the form 075/U after passing the medical commission in the Republic of Kazakhstan;

9) a copy of the preventive vaccination card;

10) medical certificate from the country of residence, confirming the absence of diseases that prevent training in the chosen specialty, the conclusion of a narcologist and psychiatrist;

11) document confirming the presence or absence of a criminal record; existence

12) certificate of current bank account to confirm solvency. The certificate is provided after successfully passing a competitive selection (interview) process for the conclusion of an agreement on the provision of educational services. The certificate shall be valid for no more than 5 working days at the time of contract conclusion. The certificate indicates an amount of at least the cost of payment for one year of study and accommodation in a student dormitory. In case of insufficient funds on the immigrant's current account, the educational organization decides to refuse to conclude an educational services agreement.

2. The invitation and visa is issued by the department for work with foreign students of the University after the signing of the enrollment order.

The fee of education is 3000000 tenge per year.
